Type of data collected

Personal data collected on the site of the Consortium are:

- *Browsing data* (cookies, usage data and access to restricted areas, user IP and others)

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data, whose transmission is implicit in the use of Internet communication protocols, including the data of the IP addresses and the system log data necessary for the correct operation and maintenance of the site. This data is not collected to be associated with identified parties. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning. The data in question could also be used, at the request of the competent judicial authority and with the guarantees provided by law, to ascertain responsibility in case of any computer crimes committed against the site. We do not use cookies to transmit information of a personal nature.

- *Cookies*

No personal data of users is acquired by the site. We do not use cookies to transmit information of a personal nature, nor are used persistent cookies of any kind, or systems for tracking users.

The use of session cookies (which are not stored permanently on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers necessary to allow the safe and efficient exploration of the site.

Details and purposes of Personal Data processing

- **Contact form**

By filling out the contact form with personal Data, the Users consent to the use indicated in the header of the form.

Personal Data collected: e-mail, name, role and company.

- **Mailing list or newsletter**

By registering to the mailing list or the newsletter, the user's email address is automatically added to a list of contacts to which email messages containing information relating to the website, project and partners activities may be transmitted. The user's email address could also be added to this list as a result of Website registration.

Personal Data collected: name and e-mail.

The explicit and voluntary contact via emails to the addresses indicated on this website involves by its very nature the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the message.

Method of treatment

Personal data are processed by the Data Controllers using IT tools and paper forms, acquired and stored by Partners, external party hosting the website and technical staff in charge of the processing. Specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access, in compliance with the EU Regulation 679/2016.

The data can be viewed by the EU exclusively for the purposes of administrative checks related to the project and in a confidentiality regime.

The treatment will last no longer than is necessary for the purposes for which the data were collected. For the document conservation obligations related to the reporting of the project mentioned above, they will be kept for a period of not less than 5 years from the end of the project.

Rights of the interested party

At any time, the interested party can exercise the rights on the data provided (articles 15, 16, 17 18, 20, 21 of EU Regulation 2016/679), writing to info@region4permed.eu. In particular, each interested party has the following rights:

- right of access, for example the ability to access all personal user information;
- right of rectification, for example the possibility of obtaining the updating of inaccurate personal data without justified delay;
- right to be forgotten, consisting in the right to cancel personal data;
- right to restriction of processing, when the subject obtain from the controller restriction of data processing where one of the case described by art. 18 of Regulation 679/2016 applies;
- right to data portability, allows individuals to obtain and reuse their personal **data** for their own purposes across different services;
- right of withdrawal of consent at any time;

- right to lodge a complaint with a supervisory authority in the event of a violation of data processing (Article 77 of Regulation 679/2016), except for cases provided in Chapter III, Article 2- Legislative Decree 101/2018);
- right to an effective judicial remedy against a supervisory authority in cases described by Article 78 of Regulation 679/2016;
